Information

How does the law affect you?

From 30th March 2008, smoking in the following public places and more will be illegal:

- All Public Transport
- Bars
- Bus Shelters
- Cafes
- Church Halls
- Clubs & Pubs
- Hospitals
- Hotels & Casinos
- Restaurants
- Schools
- Shops
- Taxis
- Theatres
- Workplaces
- Work Vehicles – Vans and Lorries

There are scarce few exemptions to this legislation.

Certain designated rooms in psychiatric units, interview rooms, residential accommodation and private vehicles are examples.

What does the law require from you?


- The law will require, simply, that you do not smoke in any of the aforementioned public places.
- Your business / workplace / work vehicle must display no-smoking notices.

What if I don't comply?

- Fines of up to £5000 could be imposed.
- Bridson & Horrox can help you take the necessary steps to ensure you provide the required signage, and prevent incurring a heavy fine.

Signage

What signage do you have to display?

- No smoking signs must be displayed in a prominent position at every public entrance to smokefree premises. The following must be displayed:

No smoking.

It is an offence to smoke in these premises.

- The signs must be a minimum of A5 in size (210mm x 148mm)
- In addition to the compulsory wording, the sign must display the international no-smoking symbol no smaller than 70mm in diameter.
